Proposed extension to Crouch End 'A' and 'B' Controlled Parking Zones (CPZ)

Dear Resident or Trader,

I write to inform you that the Council proposes to extend the Crouch End A and B Controlled Parking Zones (CPZ) to include the roads shown on the attached plan. This is in response to numerous requests from residents asking for their streets to be included in the zone.

Whilst your own road is not included within the proposed extended zone, we are taking this opportunity to inform you of our proposals because of the possibility of increased demand for parking in this and other nearby streets.

The Statutory Notification document sent to residents in the proposed CPZ extension area and dated 16 September gives a period of 21 days in which any and all interested parties can comment on the Council's proposals.

As no measures are planned or being considered for your road, the detail set out in the Statutory Notification letter does not apply to your road. However we take this opportunity to invite you to 'have your say' and comment on parking issues in your area.

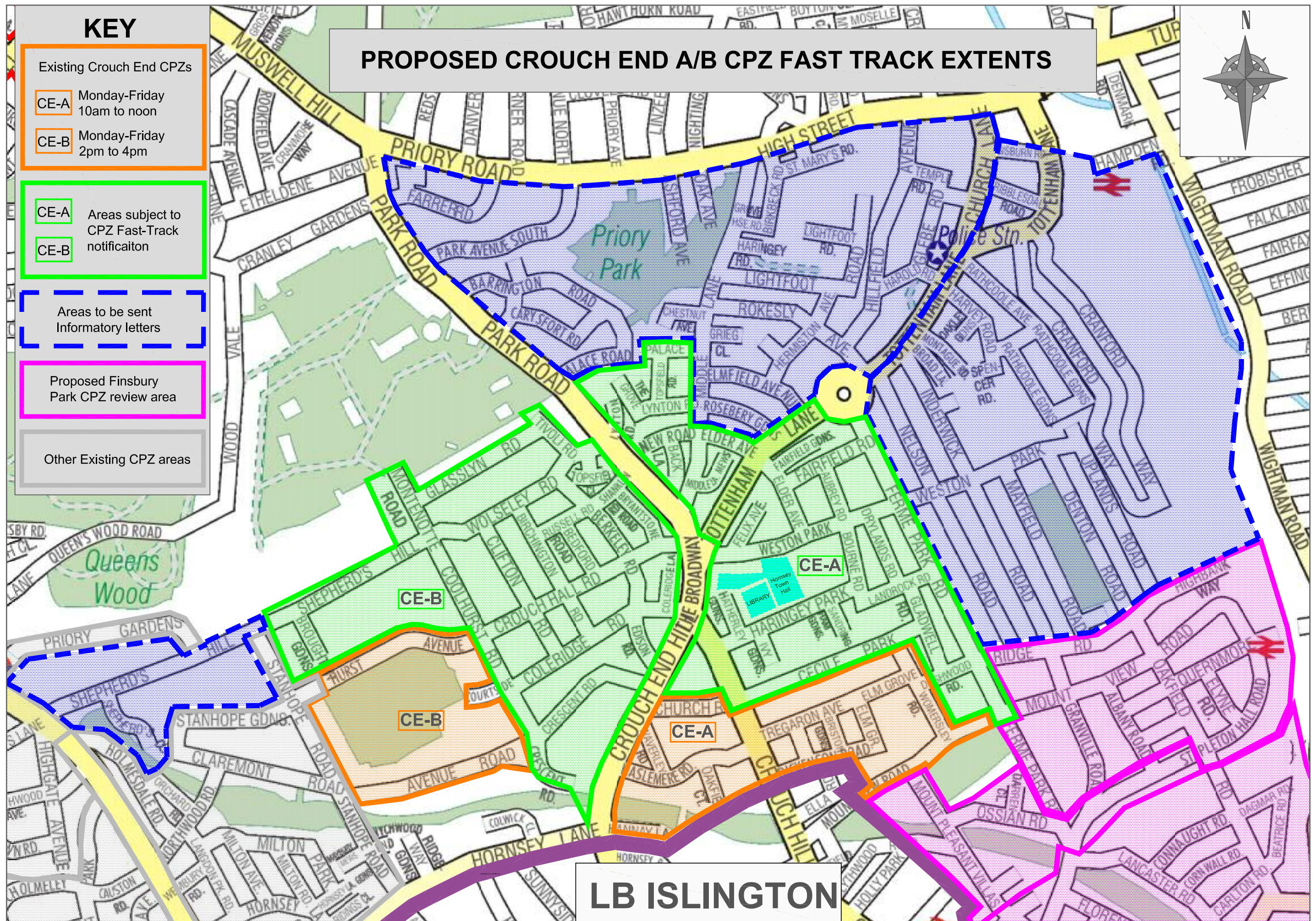
Should we receive many requests to review parking in your own and/or other local roads, we may well contact you again as we examine our 2011/12 Parking Programme, to consider how we can address any issues that may arise.
