

# Consulting you on the Hornsey Station Controlled Parking Zone (CPZ) Proposal Phase 2 Consultation leaflet



Closing Date 30 October 2006

## Consulting you on the Hornsey Station CPZ. What has the consultation told us?

In July 06, we consulted you to ask your views on whether or not your area would benefit from having a Controlled Parking Zone (CPZ). We received over 1,150 completed questionnaires. More detail on the consultation results from the first phase of the consultation can be found on the Haringey website.

Your feedback has enabled us to identify a smaller area where there is support for a parking scheme (see area marked with a green line on the map on pages 3 & 4). However we are asking for your views again to verify this. As mentioned, this smaller area has been identified where there was support for a CPZ in the first phase of consultation and takes into account practical considerations (i.e. an area with logical boundaries, for example to the end of the road).

The feedback we have received from the first phase of consultation indicated that respondents in the area marked in green preferred parking controls to operate **Monday-Friday for two hours**. This leaflet will give you another opportunity to provide feedback on what timings you think are suitable for a possible CPZ.

For the areas **outside** the green line, there will be **no change** to parking controls as a result of this consultation and **no further consultation**.

## Why have we arranged a second phase of consultation about a smaller CPZ in your area?

This second phase of consultation has been arranged to give you another opportunity to give your views on the roads included in the smaller modified area.

**If you have already responded to the consultation document** sent in July and do not wish to respond again, please be assured that your original feedback is still valid and will be included in our final analysis of results.

If you responded last time and wish to give **different or additional feedback**, we will use this **instead** of the feedback you have already provided.

## How can you let us know your views on this smaller modified area?

We would like your feedback on the details of the scheme and the operational hours suggested.

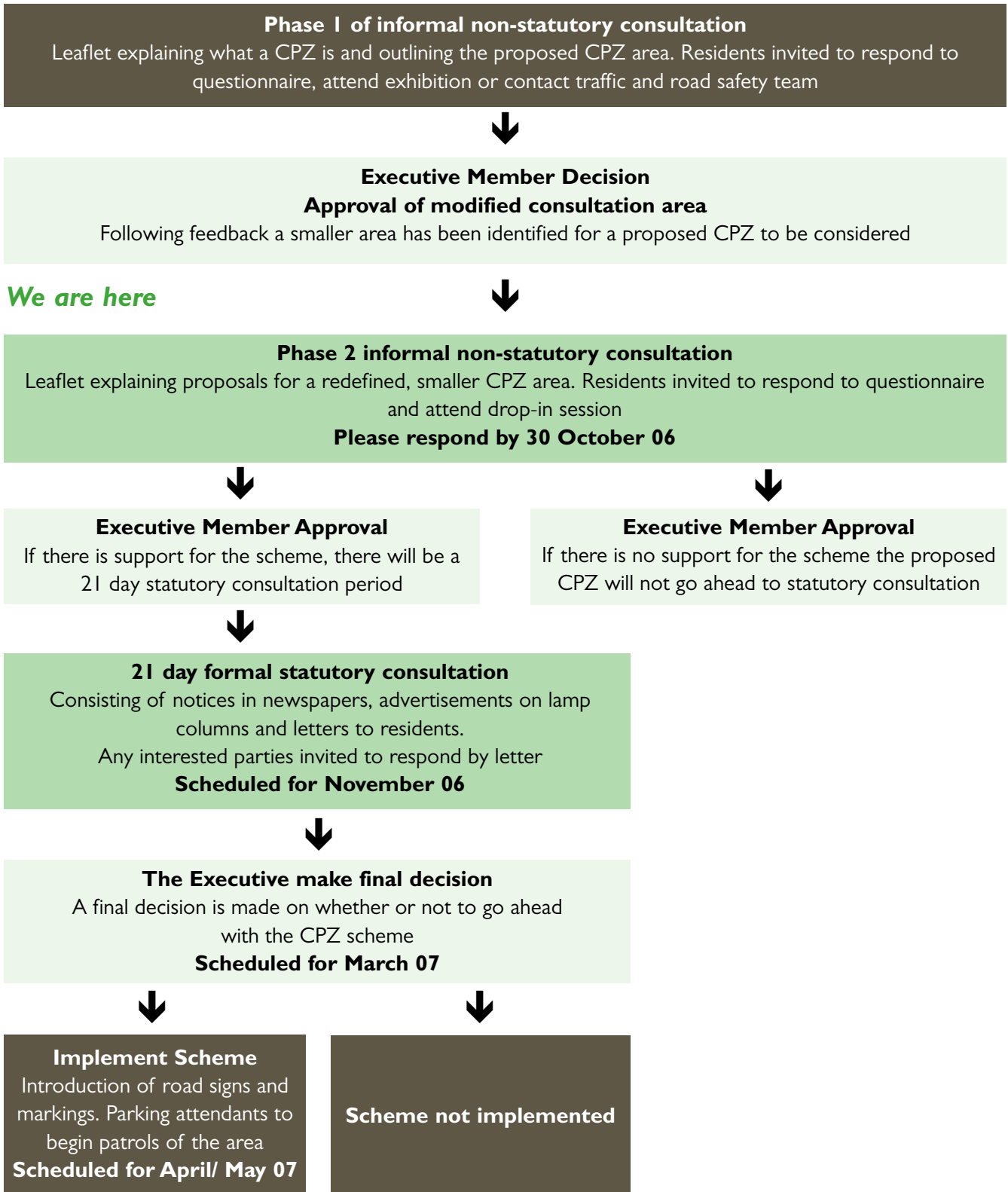

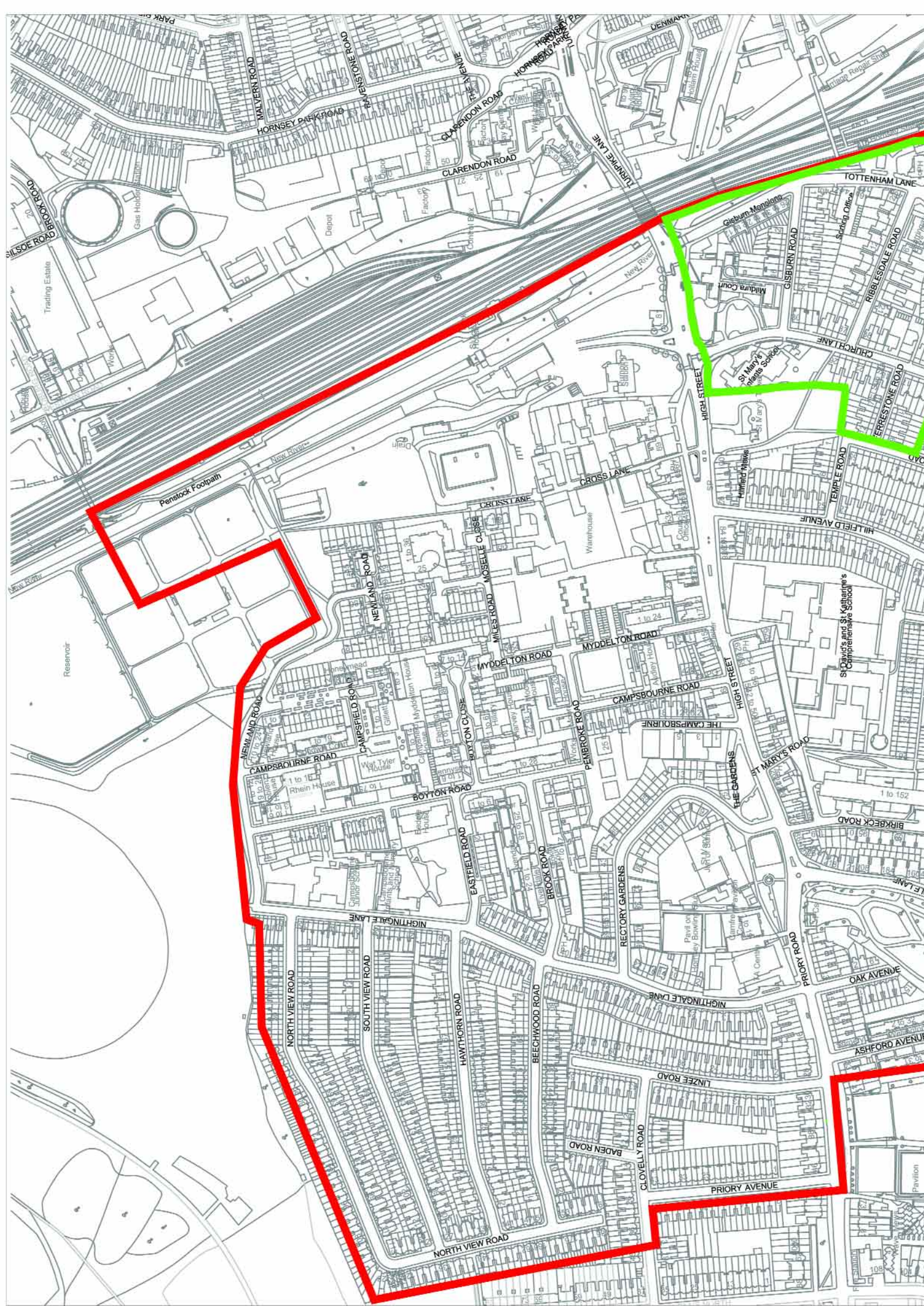
## What will happen next?

The consultation process is shown in the flowchart below.

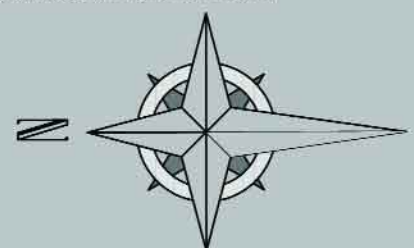
Key: ■ Community involvement ■ Decision Making **The Executive:** The council's decision making board



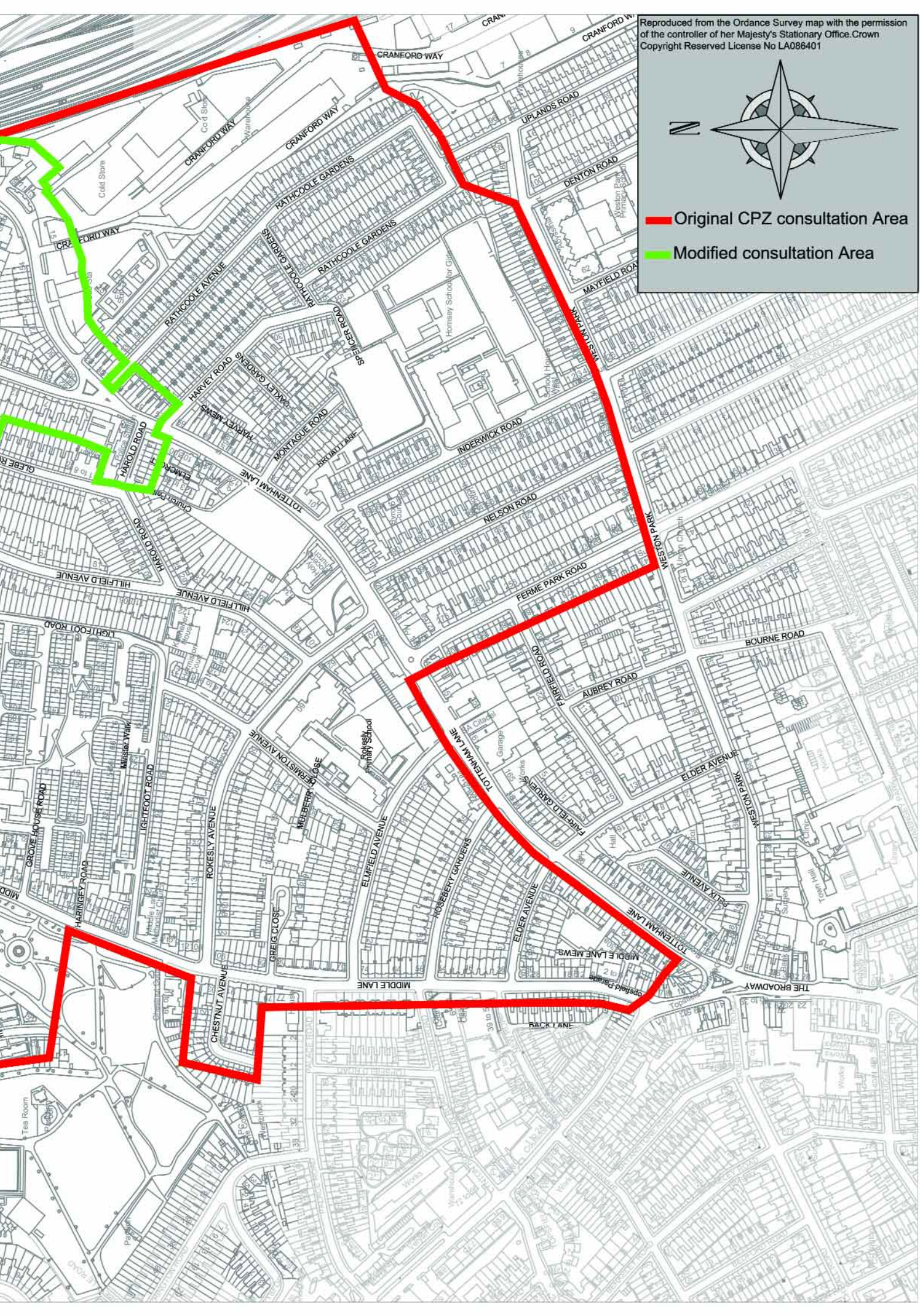








**Original CPZ consultation Area**
